# International Adult and Continuing Education Hall of Fame European Chapter

#### Status and contribution of HOFE Members

Following the <u>2015 survey</u>, a new survey was presented to the European members of the International Adult and Continuing Education Hall of Fame (hereafter HOFE members) in November 2022. Between 1996 and 2022, <u>72 members</u> from 21 European countries were inducted into the Hall of Fame. Sixteen of them have passed away. We currently have 56 active members. A letter and a questionnaire were sent to the 56 living HOFE members. In total, we had 54 members with valid email addresses. We received 23 responses (41 percent) after three reminders (Table 1).



# 1. Year of induction

The majority of respondents have been inducted into the Hall of Fame since the previous survey in 2015 (Figure 1).

Figure 1: Year of induction





Ten respondents have active labour market status, twelve are retired but still actively involved in adult learning education and one is retired (Figure 2). Figure 2: Current work status





Figure 3: Affiliation







# 8. General comments and suggestion for the HOFE

General comments, proposals, and suggestions for the HOFE We asked the respondent to provide suggestions for the future development of HOFE (open question). There is some key point:

- ✓ I am happy to help with designing questionnaires like these so that you get the best answers out of participants.
- ✓ HOFE is all in English, it frustrates all whose mother tongue is another language.

  This is a big obstacle to an active role in HOFE
- ✓ I would like to see more help/support/advice/etc from members of HOFE to younger practitioners, researchers maybe some kind of on-line advice and guidance, reviewing papers/articles, informal support with contacts and links ..... for discussion
- ✓ We live in times of interconnected crises, which include a crisis of popular adult education. We need to create better, and more imaginative links between a planet in crisis and the hopeful praxis of popular education and learning democratic activism. Links that challenge authoritarian populism, stifling paternalism and the religion of capitalism. We need to articulate and ground ideas of learning societies, cities, communities and neighbourhoods, and chronicle the many and varied initiatives designed to help create a more sustainable, inclusive and dialogical world. To build on the work of the 2019 Report on Adult Education in the United Kingdom, for instance, especially the Research Circle focused on Dialogue, democracy and community....
- ✓ Acting as a partner in conferences
- ✓ Align policy work/advocacy to EAEA and ICAE, carve out specific space in advocacy that is complementary not independent. Offer EAEA and ICAE areas of expertise and access to influence at the national/EU/International level
- ✓ Let us develop HOFE Summer School on ALE in a rotating model in association with HEIs
- ✓ Commun bibliometrics projects on Adult learning research
